OUTSIDE SCHOLARSHIPS, LOANS, & LOAN REPAYMENT OPTIONS

There are a number of private agencies and organizations that provide scholarship and low-interest loan assistance to medical students. The eligibility criteria and deadlines vary according to the guidelines established by the organization; these funds can be merit-based and/or need-based.

Pritzker's policy, if a student receives any outside award, is to replace or reduce loans. If a student receives an award from an outside source after a financial aid award has already been determined, he or she **must** notify the Office of Financial Aid in writing of the additional scholarship.

LOAN REPAYMENT OPTIONS

The National Health Services Corps loan repayment option is a federal government program open to medical students who agree to practice full-time for at least two years or part-time for four years at an NHSC-approved site. The NHSC was recently revised to include:

- ✓ **Increased Financial Support.** The Corps' loan repayment program now begins with an initial award of up to \$60,000 for two years of service. You may receive up to \$170,000 in loan repayment for completing a five-year service commitment and, with continued service, may be able to pay off all eligible student loans.
- ✓ **More Flexible Options to Complete Your Service.** The loan repayment program now offers three options for fulfilling your service obligation - a two-year full-time contract, a four-year half-time contract, and a two-year half-time contract.
- ✓ **Increased Credit for Teaching.** The service obligation for clinical practice hours has been updated to include a 20 percent credit for teaching and a 50 percent credit for teaching at a Teaching Health Center.
