Harvard has designated Title IX Coordinators throughout the University to help address issues of sexual and gender-based harassment within their specific school or unit. The Title IX Coordinators play an integral role in carrying out the University's commitment to provide a positive learning, teaching and working environment for the entire community.

The local Title IX Coordinator's responsibilities include receiving information about allegations of unwelcome conduct of a sexual nature, providing interim measures, and serving as resources for questions about sexual and gender-based harassment. Title IX Coordinators are knowledgeable about, and will provide information on the University Policy and Procedures and on the wide range of resources available to the community.
